



On **March 13th** DEQ issued Notice of Violation and Order **#5541-15** to you and the EQC docketed it as **#15-5202**. You did not appeal the Order to the Council. Thus, the Order became final and the Council held a public meeting on **May 19, 2015** and approved the Notice of Violation and Order.


