Thank you for submitting your comment regarding the EPA's preliminary review of the proposed revisions to Chapter 6, Section 13, Nonattainment new source review permit requirements, of the Wyoming Air Quality Standards and Regulations (WAQSR). The Wyoming Department of Environmental Quality – Air Quality Division (Division) sincerely appreciates the EPA's comment elucidating a typographical error within Section 13(b), Definitions, regarding an incorrect reference in the definition of "Net emissions increase." The Division recognizes this error and intends to incorporate the EPA's suggested revision into the next iteration of the proposed regulation as it moves forward in Wyoming's statutory rulemaking process to the Environmental Quality Council.

The Division is appreciative of the time and effort that the EPA has committed in conducting its preliminary review of the proposed revisions to WAQSR Chapter 6, Section 13, Nonattainment new source review permit requirements. The Division also acknowledges that the EPA will not come to a final conclusion regarding Wyoming's nonattainment new source review SIP revision until it takes action on the SIP submittal through its own public notice-and-comment rulemaking. The Environmental Protection Agency has completed a preliminary review of Wyoming's March 2015 Nonattainment New Source Review SIP Revision, as proposed on your state's website. The revision will add Chapter 6, Section 13, Nonattainment New Source Review Permit requirements to the state's SIP. Our comment, which is detailed below, addresses what appears to be an administrative error.

Section 13(b), Definitions


Net emissions increase

In the definition of "Net emissions increase" (i)(A), the reference to paragraph (c)(i)(B) should be (c)(ii)(B).

We understand that you intend to consider and respond to all comments received on this public comment version before finalizing the SIP. Please note that we will only come to a final conclusion regarding the Nonattainment New Source Review SIP Revision when we take action on the SIP submittal through our own public notice-and-comment rulemaking.
