NOTICE OF VIOLATION

AND

ORDER

NOTICE IS HEREBY GIVEN THAT:

- On December 9, 1980 personnel of the Water Quality Division of the Department of Environmental Quality conducted an on-site inspection of the wastewater disposal pond constructed by Husky Oil Co.;
- 2. This facility is located in Section 21, T14N, R115W near Highway 410 in Uinta County.
- 3. Mr. Everett Murray, Box 743, Robertson, WY was on site and stated the pond was constructed on or about November 1, 1980.
- 4. The pond was in use and an oil slick was visible during the on-site inspection, on December 9, 1980, by personnel of the Water Quality Division of the Department of Environmental Quality;
- 5. Wyoming Statute 35-11-301(a)(v) and Section 4, Chapter III of Wyoming Water Quality Rules & Regulations require a permit to construction, install or modify a sewerage system treatment works, disposal system or other facility capable of causing or contribution to pollution;
- The Department of Environmental Quality, Water Quality Division has not received an application nor issued a permit to construct a wastewater disposal pond at the above location prior to construction;
 - Husky Oil Co. is in violation of W.S. 35-11-301(a)(v) and Chapter III of Wyoming Water Quality Rules and Regulations.
- 8. Any person who violates any provision of the Environmental Quality Act, or any rule, standard, permit, license or variance adopted thereunder, is liable to a penalty of ten thousand dollars (\$10,000.00) for each day of violation, which penalty may be recovered in a civil action brought by the Attorney General in the name of the People of the State of Wyoming.
- 9. This notice is being sent to you pursuant to W.S. 35-11-701(b) which requires that, in any case of the failure to correct or reme dy an alleged violation, the Director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible.

ORDER

WHEREFORE, IT IS HEREBY ORDERED THAT:

 Husky Oil Co. submit complete "as built" plans and specifications and all pertinent design information of the wastewater disposal pond to DEQ within thirty (30) day after receipt of this notice. 3. All parts of the waste disposal pond which do not meet minimum applicable standards shall be upgraded to conform to such standards.

THIS ORDER is final and binding unless, not later than ten (10) days after the the day of its postmark, it is appealed by filing a written request for a hearing before the Environmental Quality Council. The request should be mailed to Robert E. Sundin, Executive Secretary, Environmental Quality Council, 401 West 19th Street, Cheyenne, Wyoming 82002.

NOTHING IN THIS ORDER shall be interpreted to in any way limit or contravene with any other remedy available under the Environmental Quality Act, nor shall this Order be interpreted as being a condition precedent to any other enforcement action.
