With reference to the Notice of Violation and Order, Docket No. 3452-03, I would like to appeal the decision based on the following facts:

- 1. Sandy Crossing was sold on 16 March, 2001, at which time Chief Operator prior was Curtis Martin, who was hired by the new management and he was still the Chief Operator after 16 March 2001.
- Curtis Martin quitted on (not fired) 12th January, 2002 from Sandy Crossing and Mark Huffstetler was Backup Operator at this time.
- 3. We have not terminated Mark Huffstetler's services from Sandy Crossing since then, and he is still a certified operator for us. We do not have any other understanding that he is not an operator for us.
- 4. I am shocked to find that in Docket Number 3452-03, paragraph 1. Line 3-5 that "Mark Huffstetler was terminated as the Backup Operator in July 2002 leaving Sandy Crossing without certified operators". Who authorized the above termination. Curtis Martin has not been an employee of Sandy Crossing since January, 2002. If Curtis Martin has made any representation to any authority to represent Sandy Crossing after his employment with us, then that agency has been misrepresented by Curtis Martin not by Sandy Crossing.
- 5. We have met the requirements of monthly and yearly sampling, as required.
- I have been genuinely and sincerely interested in becoming a certified operator. I hold a B.Sc. in Agriculture and understand the requirements for the cause.

- 7. While managing the business, (Sandy Crossing) I was also working with United States Chamber of Commerce. Few months ago, I have quitted (after six years of serving the Chamber) to fully focus on Sandy Crossing, where we have sustained and created employment for over ten employees.
- 8. As required, on the Order of Docket no. 3452-03, page 2, Para 1. Sandy Crossing will acquire a certified Chief and Back up Operator by March, 2003, I hereby assure that I will take steps to become Operator. Mark Huffstetler, is willing to continue to provide us services, as required.
- 9. We will continue to abide by the Order of Para 2. and Para 3, Docket No. 3452-03, Page 2 and other requirements as required by various regulatory agencies.
