AMENDED SCHEDULING ORDER

The Parties appeared for a pre-hearing conference in this matter on Tuesday, February 22, 2018 at 3:45 p.m. via telephone conference call in the Board of Equalization Board Room in the Herschler Building, 122 West 25th St. Cheyenne, Wyoming. Appearing at the conference on behalf of Delton Tinsley was Ray Hunkins. James LaRock appeared on behalf of the Wyoming Department of Environmental Quality Department.

Nick Agopian presided over the conference and entered the following timelines:

1. Deadline for service of Interrogatories, Document Production Requests and other discovery is March 12, 2018. Responses to discovery shall be served no later than April 2, 2018.
2. Dispositive motion shall be filed by April 2, 2018. Responses are due April 30, 2018. Dispositive hearing will be held immediately before the final hearing on May 23, 2018.
3. The parties shall exchange a list of will call and may call witnesses no later than May 18, 2018.
4. Exhibits shall be filed with each party and with the Council no later than 12:00 noon on May 18, 2018. Please provide the exhibits to the council in both digital and paper form. The Council has an e-filing system. The system will number your Exhibits starting with the number 1 but you must identify them as final exhibits NOT AS PLEADING EXHIBITS. You should have received an email with your username and password, if you have not please call Joe Girardin at 307-777-7170. When you are ready to file something using this system call and talk with Joe Girardin he will assist you in making sure your documents get filed correctly. Once the system numbers your exhibits you will need to assign the same numbers to the respective physical paper exhibit.
5. The final hearing in this matter will start May 23, 2018 after the rule hearing that starts at 9:00 a.m. and continue the 24th if necessary. The location of the hearing will be in room 171, the Elk Room of the Game and Fish Department, 5400 Bishop Boulevard Cheyenne WY 82006.
