Pursuant to the order issued on November 3, 2023, the Wyoming Department of Environmental Quality (Department), through the Wyoming Attorney General's Office, hereby responds to Basecamp Teton WY SPV LLC's (Basecamp) motion to intervene in the above-captioned case. The Department takes no position on Basecamp's motion to intervene. The Department notes, however, that the Council allowed the permittee to participate as a party in a previous case where a citizen group asked the Environmental Quality Council to suspend a permit pending the outcome of the administrative permit appeal. *See In the Matter of Basin Electric Power Cooperative Dry Fork Station Air Permit CT-4631*, EQC Docket No. 07-2801 (2008).


