**STIPULATION OF DISMISSAL OF ACTION**

Appellants Jackson Hole Conservation Alliance and Teton Village Alliance (the “Appellants”), and Wyoming Department of Environmental Quality Air Division (“Appellee”), by and through their undersigned attorneys, hereby stipulate and agree to dismissal of this action pursuant to Rule 41 of the Wyoming Rules of Civil Procedure.

1. On March 29, 2024, the Appellants filed a timely appeal of Permit to Construct #P0036295.

2. On June 12, 2024, the Council entered an Order Setting Prehearing Conference, Final Hearing, and Requiring Disclosure, which set the matter for an administrative contested case hearing from October 23 to October 25, 2024 in Cheyenne, Wyoming, as well as the prehearing deadlines.

3. Pursuant to Rule 41(a)(1)(A)(ii) of the Wyoming Rules of Civil Procedure, “the [Appellants] may dismiss an action without a court order by filing . . . a stipulation of dismissal signed by all parties who have appeared.”

4. This action will be dismissed with prejudice.

5. Each party shall bear their owns costs and fees.
