
COME NOW, Andreas Petroleum (“Andreas”) and the State of Wyoming, Department of Environmental Quality, Water Quality Division (“DEQ/WQD”), by and through their respective counsel, and hereby file this joint status report in the above-captioned matter.

1. By Order of Continuance dated May 31, 2024, the Hearing Officer continued this matter until such time as the parties file a Motion to Dismiss, a Motion for a Scheduling Conference and Request for Final Hearing, or such other pleadings as they believe necessary. The Hearing Officer also ordered the parties to submit joint status updates not more than 180 days from the filing date of the previous update.
2. Since the parties submitted their Third Joint Status Report, Andreas has continued to work with DEQ/WQD to resolve the NOV and Order as well as other issues connected with the National Park Service and the Environmental Protection Agency which result from the site being located within Yellowstone National Park.
3. Andreas, DEQ/WQD, and the National Park Service continue to work together to draft the documents necessary to finalize the agreements they have reached to resolve outstanding claims and implement the remedy plan approved by DEQ/WQD and the

National Park Service. In reliance upon those reached agreements, Andreas has started implementing the approved remedy plan.

4. The parties anticipate that the necessary agreements will be finalized and executed prior to the time another joint status update is due in this matter.


