Public Notice

Lafarge West, Inc. of Longmont, CO has applied for a revision of its mining permit for Permit No. 752, dated October 23, 2007 from the Land Quality Division of the Department of Environmental Quality for the State of Wyoming. The mining permit area for the mining of sand and gravel is located in: the S1/2 of the NW1/4, the SW1/4 of the NE1/4 of Section 30, Township 15 North, Range 74 West of the 6th P.M., in Albany County, WY. The Lafarge Talbott Pit is approximately 10 miles southwest of Laramie, WY. This area can be found on the Miller USGS quadrangle map. The mining operation will begin no later than 2014 and is estimated to continue for 20 years. The land, after mining, will be returned to agriculture, grazing, and permanent water impoundment. Information regarding the proposed permit revision may be reviewed in the Office of the Land Quality Division, Department of Environmental Quality in Cheyenne,

WY, the office of Lafarge West, Inc. in Laramie, WY, or the Albany County Clerk's Office in Laramie, WY. An index identifying the proposed changes is included with the permit revision. Written objections to the proposed permit revision must be received by the Administrator of the Land Quality Division, Department of Environmental Quality, Herschler Building, 122 West 25th Street, Cheyenne, WY 82002, before the close of business on August 31, 2009. Only the permit revision is open for public review. If an objection is submitted, a public hearing shall be held within twenty (20) days after the final date for filing objections, unless a different period is stipulated to by the parties. The Environmental Quality Council or Director shall publish notice of the time, date and location of the hearing or conference in a newspaper of general circulation in the locality of the proposed operation once a week for two (2) consecutive weeks immediately prior to the hearing or conference. The hearing shall be conducted as a contested case in accordance with the Wyoming Administrative Procedure Act (W.S. §16-3-101 through §16-3-115), and the right of judicial review shall be afforded as provided in that act. All parties as given in W.S. §35-11-406(j) will be mailed a copy of this notice. The Wyoming Oil and Gas Commission will be mailed a copy of the application mine plan map as required in W.S. §35-11-406(j).
