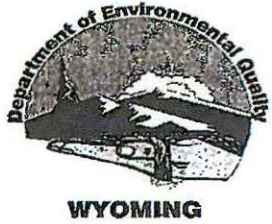

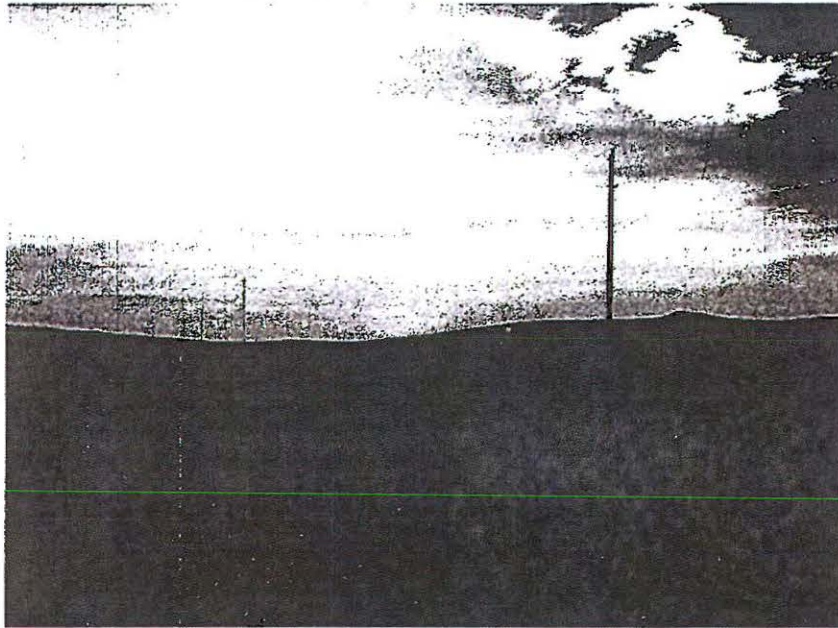
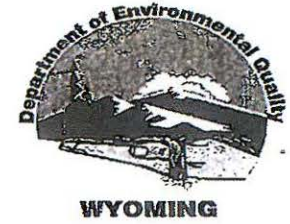

On October 2, 2013 Jamie O'Dell, Jessi Andrews, and I traveled to the Two Elk Power Plant site to investigate construction progress under Air Quality Permit CT-1352B. We were met on site by Mr. Brad Enzi, Vice President for Two Elk Generation. It was noted that the road into the plant had been damaged from rain runoff and was overgrown with weeds. At the facility site, I asked Mr. Enzi for the status of the water wells. During a site visit on April 13, 2011, Mr. Enzi had stated that three water wells were to be drilled as continued construction of the project. The water wells have not been drilled to date. The next construction activities to take place are to move power lines to the east, out of the way of further construction. Mr. Enzi stated that the most recent construction activity had been to remove scoria in the area shown in the attached photos. He stated that this work had been done in the last year. In reviewing photographs from the April 13, 2011 site visit, it appears that the scoria had been moved in early 2011, but it is possible that more had been removed during the last year. Mr. Enzi also informed us that current plans include building a gas turbine power facility at the site. No construction activities could be confirmed to have taken place in the last twenty-four months.

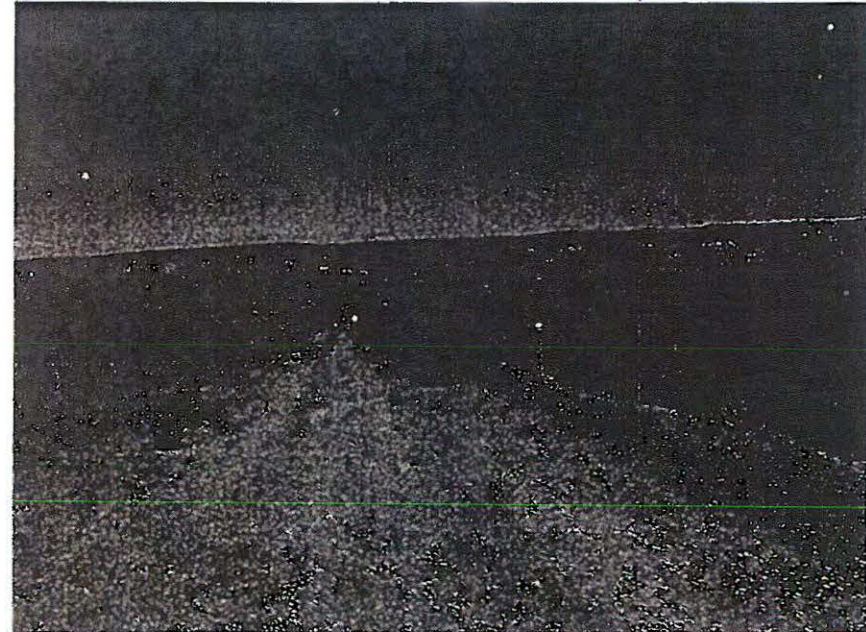
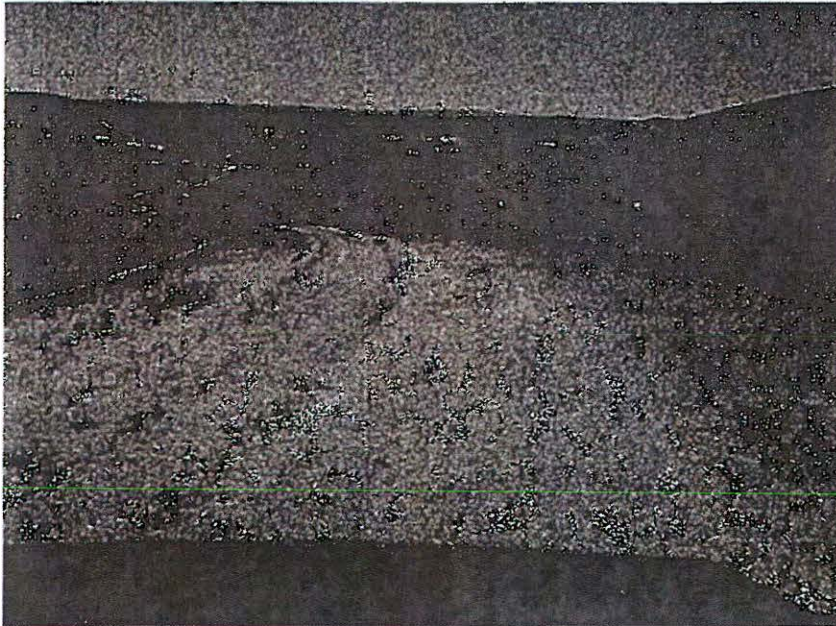
