

**The Wyoming Department of Environmental Quality
Air Quality Division (WDEQ-AQD)
Wyoming Air Quality Advisory Board Meeting**

The Wyoming Air Quality Advisory Board will meet on April 22, 2014 at 9:00 AM, in the BP Collaboration Center, Room 209, which is located in the Energy Innovation Center building at 1020 E. Lewis Street, Laramie, Wyoming. The Air Quality Division (AQD or Division) is requesting the Board's consideration on proposed changes to Wyoming Air Quality Standards and Regulations (WAQSR), Chapter 3, General Emission Standards, Chapter 5, National Emission Standards, Chapter 6, Permitting Requirements, Chapter 7, Monitoring Regulations, and Chapter 11, National Acid Rain Program. Most of the changes involve annual updates to portions of the State Air Regulations which are adopted verbatim by reference from the Code of Federal Regulations (CFR). These changes affect Chapters 3, 5, 6 and 11. The Division is also proposing changes to Chapter 7, Section 3, to update a citation to a Federal Register article. The same citation is also being updated in Chapter 6, Sections 3 and 4. Also in Chapter 6, Section 4, the Division is proposing to update PSD (Prevention of Significant Deterioration) rules to specifically list a new minor source baseline date for fine particulate. Chapter 3, Section 9, and Chapter 6, Sections 4 and 14, involve changes to the State Implementation Plan (SIP). The AQD will submit these SIP changes to the Environmental Protection Agency (EPA). The Division will also be presenting information on the five-year review of the Natural Events Action Plan (NEAP) for the Powder River Basin in Wyoming. The public is invited to attend the meeting and may comment on all matters before the Board. All oral comments made during the meeting, and signed comments hand-delivered to Steven A. Dietrich at the meeting, will become part of the public record. Written comments will also become part of the public record if they are signed by the commenter and submitted to Steven A. Dietrich, Administrator, DEQ/AQD, Herschler Building 2-E, 122 W. 25th Street, Cheyenne, Wyoming, 82002, or faxed to 307-777-5616, by the close of the meeting on April 22, 2014. Emailed comments will not be included in the public record. Copies of the agenda, public notice, Natural Events Action Plan (NEAP) Five-Year Review memorandum, and the proposed regulations, are available for public inspection at the Department of Environmental Quality, Air Quality Division, Herschler Building, 2nd Floor, 122 W. 25th Street, Cheyenne, Wyoming.
