

The Environmental Quality Council finds that the questions raised in this case by the Petitioner, Cathy Killean, have been the subject of recent litigation; the Wyoming Supreme Court has reviewed the arguments raised by Ms. Killean; and the Court has found no basis for relief under the provisions of the Environmental Quality Act.
