

ORDER APPROVING THE ADMINISTRATIVE ORDER ON CONSENT

The Wyoming Department of Environmental Quality, Solid and Hazardous Waste Division (Department), issued an *Administrative Order on Consent* (AOC) to the Big Horn County Solid Waste Disposal District (District) on November 13, 2014. The Department filed that AOC with the Environmental Quality Council (Council) on the same day. The purpose of the AOC is to establish a schedule for the District to take specific actions related to its enrollment in the Cease and Transfer Program (W.S. 35-11-528 through W.S. 35-11-532). The Council, having reviewed the AOC and the motion for its approval:

HEREBY ORDERS THAT the referenced *Administrative Order on Consent* filed with the Council on November 13, 2014 is approved.


