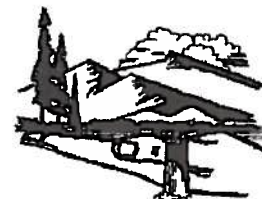

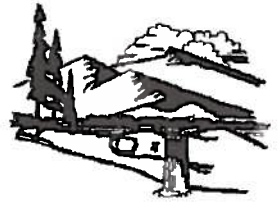

SUBJECT: Request for review of proposed rules for statutory authority

The Department of Environmental Quality, Water Quality Division (WQD) is proposing to revise Chapters 15 and 25 of the Water Quality Rules and Regulations. The proposed revisions move the contents of Chapter 15, Appendix C into new Appendix B of Chapter 25, reserve the rest of Chapter 15, and substantially edit Chapter 25.


The Water and Waste Advisory Board reviewed the rules during the June 14, 2013, September 19, 2013, April 18, 2014, and July 25, 2014 meetings. The Board recommended adoption of the rules to the Environmental Quality Council at the July 25, 2014 meeting. WQD has reviewed the requirements of 35-11-302(a)(iii) and(iv) of the Wyoming Environmental Quality Act and has determined this rulemaking to be in procedural compliance with the statute. WQD has reviewed and responded to the Takings Checklist provided by the Attorney General's Office. WQD is now seeking a review of the proposed rules for statutory authority prior to submitting the rules to the Governor's Office for permission to proceed to formal rulemaking.

Per the Attorney General's Rules Handbook, you will find attached a copy of the draft memo to Governor Mead, a copy of the draft Statement of Principal Reasons for Adoption, a copy of Chapter 25 in strike and underline format, a copy of Chapter 25 in clean format, a copy of Chapter 15 in strike and underline format, a copy of Chapter 15 in clean format, and a response to the Attorney General's Takings Checklist.
